CERCLA Superfund Cleanup - Demolition, Remediation and In-Situ Thermal Desorption (ISTD) for PCBs, VOCs, TCE (and degradation products); petroleum hydrocarbons, including 1,2,4-trimethylbenzene; asbestos containing material (ACM); and lead-based paint in building materials and soil. EPA Region 7 approved the work plans and health and safety plans for the demolition and Removal Action. The work plans and health and safety plans are specifically designed to minimize dust, protect workers, as well as the adjacent Boys & Girls Club, along with residents and visitors in surrounding neighborhoods.

Scope of Work:

The team completed asbestos, lead paint, and hazardous materials surveys in a total of fourteen (14) buildings. Of the 14 buildings, four buildings were abated of all environmental hazards and demolished. Two additional buildings were slated for partial demolition after appropriate abatements. The team oversaw the abatement of all confirmed ACBMs in accordance with technical specifications prepared by a licensed project designer prior to building renovation and/or demolition. The team completed follow-up waste characterization sampling for lead to document compliance with RCRA regulations with regard to the disposal of building demolition wastes.
